Terms & Conditions:

- Prices-The rates are firm, Exclusive of GST and shall not vary till completion of total work.
- Specification for Scope of work-
 - PRW shall strictly abide by the specifications as per contract agreement with the Employer/Client/PMC.
 - PRW shall execute the work as per the approved QAP, drawings & specifications provided by the client.
- Term of Payment-
 - 100% Payments shall be paid on completion of work and receipt of bills duly certified by the Engineer in charge once in a month.
 - If any advance is paid to you by Cash/Cheque it shall be debited to you in RA Bills.
- Taxes-
 - TDS will be recovered from all the payments made to PRW agency.
 - GST will be paid extra as applicable as per Government norms on submission of valid documents.
 - Copy of GSTR 3B (sales declared) have to be submitted to us on or before 20th of the subsequent month for the services provided made during the previous month and payment will be released subjected to this compliance.
- Insurance/ Safety regulations-
 - All insurance for Labour deployed by PRW will be in the preview of original contract with client.

- b. You will take necessary precautions for the safety of workers, materials & staff.
- c. You will comply with all safety rules framed by the statutory authorities in the execution of work awarded to you. We shall not hold any responsibility in regard to the safety of your employees. If required PPE will be supplied by MEIL on debit able basis.
6. Sufficiency of man power-
PRW agency has to make all working arrangements, manpower as per contract agreement specifications to complete work.
7. Supervision of staff-
Work shall be executed under the supervision of principal Contractor engineers/ Client/PMC staff and as per the instructions of client.PRW agency shall also deploy necessary work men to execute the subject work as per specifications and direction of principal Contractor/ Client Engineers/PMC.
8. Inspection-
The progress of work shall be inspected by any of our representative MEIL/HPCL/EIL officials at different stages.
9. Statutory requirements-
- a. The PRW agency shall not deviate from the Work order/specifications. In case it shall be carried out only on the written order from the principal contractor or client.
- b. Submission of provident fund slips for every working employee under M/s. FIRST CHOICE PROJECTS is mandatory.
- c. Police Verification is required for all Staff & Workers and should be submitted to MEIL.
10. Damage to any property & utilities-
You should not damage any of our property during the execution of the job. In case any damage to property it shall be debited to you.
11. Termination of work order-
Any work not mentioned above but required to complete the activity in PRW agency scope, is deemed to be included in agreed rate. Any terms and conditions quoted by PRW agency previously which are inconsistent with the above terms will supersede all the terms which are inconsistent with the above. The agreed rate is overall composite rate for completing the scope of work and at to no point of time the split of the rate with respect to any individual item will be considered. In case PRW agency do not mobilize adequate or does not commence the work or does not progress satisfactorily of work or neglect or does not comply with principal Contractor instructions, Principal contractor (MEIL) reserves the rights to alter/ modify/ amend/ cancel/ terminate the work order and its terms and conditions as and when required at site, in the interest of work and on the unsatisfactory of performance of the agency within 7 days notice and take remedial measures. PRW agency shall not be entitled for any compensations or claims in such an event.
12. Others-
your scope covers providing adequate manpower for completion of the work. You must obtain necessary labor contract licenses suitable for carrying out the above job as per laws applicable at the place of working. The same must be valid during the period applicable for this contract. You shall strictly comply with all labor laws as in force during the tenure of your working at site and till the completion of the work envisaged on the work order. You will have to cover the workmen employed by you for this job under workmen's insurance policy. All the rules such as PF compensation, leave, retrenchment, compensation, etc., shall be followed by you strictly as per contract labor Act. We shall not held responsible for any default in adhering to any of labor laws as related to the clauses stated above and those, which will be coming in force/be enforced by the Government from time to time.
13. Order acceptance-
Please sign and return back the duplicate copy of the work order as PRW agency acceptance. In the event of the same is not received within 3 days it is deemed that PRW agency have accepted this work order.
14. Jurisdiction-
All disputes arising out of this Work Order will be subjected to Hyderabad Jurisdiction.
